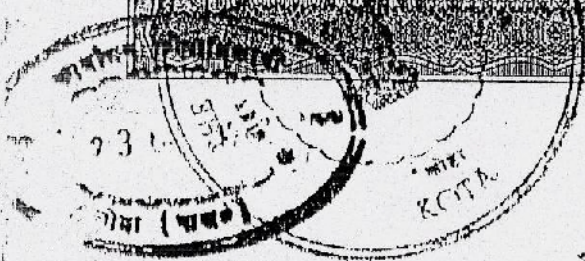
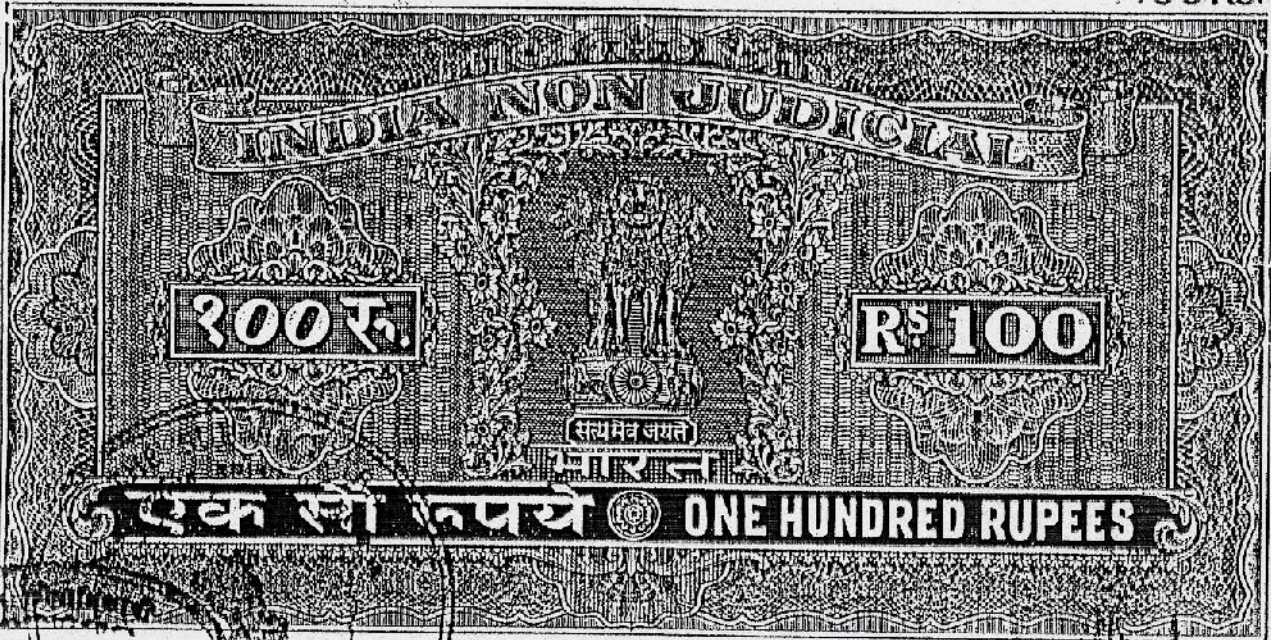

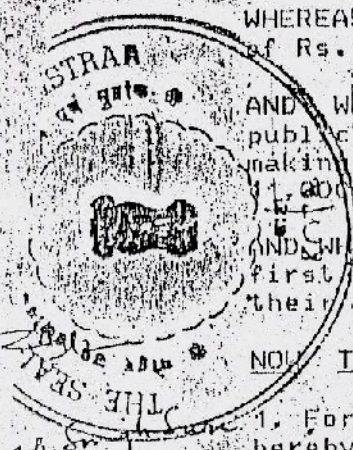
WHEREAS the settlor is absolutely possessed of a sum of Rs. 11,000/- (Rupees Eleven Thousand only).

NOW THIS INDENTURE WITNESSETH as follows :

1. For effectuating his said desire the Settlor hereby handover unto the Trustees the said sum of Rs. 11,000/- (Rupees Eleven Thousand only) to HAVE, HOLD, RECEIVE and TAKE the same forever UPON THE TRUST and with and subject to the powers, provisions, agreements and declarations hereinafter appearing and contained of and concerning the same.

2. The Trustees do hereby declare that they the Trustees shall hold and stand possessed of the said sum of Rs. 11,000/- (Rs. Eleven Thousand only), and which is hereinafter referred to as the Trust fund (which expression shall also include cash and any other property and investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or such as may be acquired by the Trustees or come to their hands by virtue of these presents or by operation of law or otherwise however in relation to these presents) UPON THE TRUST and with and subject to the powers, provisions, agreements and declarations hereinafter made and contained of and concerning the same.

3. The Trustees shall hold and stand possessed of the Trust fund UPON TRUST :

(a) To recover the interest dividends and income of the Trust Fund and to pay out of the same the charges for collection and all other outgoings if any;

(b) To pay or utilise the balance of such interest, dividend and income of the Trust Fund hereinafter referred as "The net income" and if the Trustees so desire the corpus of the Trust Fund or any part thereof for all or any one or more of the following charitable purposes and objects to the intent that the same shall relate to anything done or to be done without reference to caste, creed, religion, faith or community and in such shares and proportions and in such manner in all respects as the Trustees shall in their absolute and uncontrolled discretion deem fit:

(i) To provide medical relief and health care to the poor and needy persons.

(ii) To provide educational facilities; advancement and propagation of technical, scientific, moral, cultural education and learning of every kind.

(iii) To carry out social welfare programmes to help poor, widows, blinds, deaf & dumb peoples etc and needy persons.

(iv) To undertake, promote help or encourage the activities of rural development and the advancement of any other object of general public utility.

4. Without prejudice to the generality of the preceding clause IT IS HEREBY DECLARED that the trustees shall be entitled to pay, utilize or apply the Trust Fund and/or the income thereof for all or any one or more of the following purposes that is to say:

(a) For establishing, supporting or maintaining or helping by monetary gifts or otherwise, hospitals, clinics, health units, dispensaries, infirmaries, convalescent homes, maternity homes, homes for the blind, deaf and dumb or other disabled or aged persons, home for lepers and other institutions for medical relief.

(b) For rendering free medical aid and giving free medicines and the like to needy persons.

(c) For the establishment or help in the establishment or maintenance of educational institutions including schools, colleges and other institutions and either for general education or for technical education or for education in medicine, commerce, science, including domestic science or arts, physical education and training or that in any other subject or for any other institution for furthering the cause of education so that the benefit thereof may be available to students or members of the public.

(d) For giving scholarships and prizes to deserving students of either sex studying in schools or colleges or other educational institutions.

(e) For establishing or maintaining chairs in university, professorships, lecturerships or prize or for giving remuneration or other emoluments for essays, papers, thesis and the like and either in connection with schools, colleges, universities or other educational institutions or otherwise howsoever for advancement of education.

(f) For advancement and support of scientific, medical and historical research and for giving facilities to students, research workers, authors and others engaged in such research work and for translation of books in Oriental, Western or other languages and for helping deserving authors scholars and others by purchase or by meeting cost of printing or publishing books or otherwise and for presenting or selling them to persons, societies or institutions for the advancement of scholarship and learning.

(g) For the promotion, encouragement and advancement of education in art and artistic effort in all its branches including the knowledge, art and science of music, painting, drama, dancing, photography, sculpture and any other kind of art for the benefit of the public.

(h) For establishing, maintaining, supporting or helping by monetary gifts, donations or otherwise, the institutions for the advancement of learning such as libraries, pathshalas, fine art institutions, art galleries, industrial, technical or commercial classes or institutions and for the advancement of training such as gymnasiums and other institutions.

(i) For giving help to poor students of either sex and either by payment of fees or providing books or by defraying expenses or by other means.

(j) For building or helping in the construction or establishment or maintenance of buildings or residential quarters or hostels for the use of students of either sex and for providing recreation, canteen or other facilities to students either in such hostels or otherwise.

(k) For giving doles to the poor and the destitutes in money or kind, free food and the like.

(l) For establishing, supporting or maintaining industrial homes or institutes for the poor.

(m) For establishing, supporting or maintaining charitable institutions or establishments for the relief of poor, including homes for widows and orphans.

(n) For erecting or helping by monetary aid by way of loans advances or standing as surety or guarantor or otherwise in the erection of building or for providing accomodation, for the object of the Trust.

(o) For establishment and maintaining dramshalas and sanatoria and the like for the poor.

(p) For giving monetary aid or other help for relief from natural calamities like floods, draughts, cyclones, tempests, earthquake or otherwise.

(q) For giving loans, without interests, for any of the above charitable purposes without being responsible or accountable for any loss caused thereby.

(r) For giving donation or otherwise to any public non communal charitable institution having one or more objects similar to the objects of the trust.

5. (a) The charity shall always be called and named as " GURU NANAK WELFARE TRUST ". No other name shall be associated with said charity PROVIDED that in the absolute and uncontrolled discretion of the trustees, the name of any other individual may be associated with any particular item or items of the Trust Fund as more particularly mentioned in clause seven hereof.

(b) The office of the said " GURU NANAK WELFARE TRUST " shall be at Badgaon, Kota Bundi Road (near Gurudwara Agamgarh Sahib and / or such other place as the Trustees may decide.

6. The trustees shall be at liberty at any time to invite and receive or without such invitation receive any voluntary contributions either from the settlor or from the trustees or from any member of the public or from the government or any institution by way of donation, legacy or otherwise for all or any of the objects and charities mentioned above PROVIDED that they are not inconsistent with the provisions contained in these presents. All such contributions including any properties moveable or immovable so obtained by the trustees shall form part of property of the trust being the subject matter of these presents. PROVIDED FURTHER that it shall be lawful for the trustees in their absolute and uncontrolled discretion to decide whether they should invite or accept any donation as aforesaid and the trustees shall at all times be at liberty to refuse any donation or contribution without giving any reasons for any such refusal.

7. The trustees may allow any donor to erect a building or buildings on any land belonging to the trust for being used for the purposes of these presents. Any such donations may be accepted either

with or without any special conditions as may be agreed upon between the donor and the trustees. PROVIDED that such conditions are not inconsistent with the intents and purposes of these presents. PROVIDED FURTHER that the name of the trust mentioned in clause 5(a) and (b) hereof shall not be altered.

8. Subject to any law for the time being in force, the Trust Fund and any other money to be invested may in the absolute discretion of the Trustees be invested in modes or forms as specified in sections or provisions of the Income Tax Act, 1961 or as per its amendments from time to time.

9. (a) The total strength of the trustees shall at any time be not less than five or more than nine.

(b) The trustees named in these presents shall hold their office during life time unless resigned voluntarily.

(c) The Trustees above named shall by majority have power to nominate or appoint in writing a person as a trustee in case of death, resignation or retirement for any reason whatsoever of any trustee from the trust. the person so appointed or nominated shall hold office for life.

(d) The Trustees by a majority of decision, may remove any of the Trustee found incapable of serving the objects of the Trust because of illness or lunacy or insolvency, or for any other reason.

(e) The Trustees shall appoint one of them to act as Chairman of the board of Trustees (with power to change such appointment) and Baba Lakhwinder Singh shall be the first chairman. The chairman shall preside at all meetings. In the absence of the chairman at any meeting the Trustees who may be present at the meeting shall elect a chairman for the meeting.

(f) The board of Trustees shall have power to appoint additional Trustees on the terms and conditions as they think fit. Those Trustees shall be retired once in every three years, but so retired trustees may

be re-appointed if the Board finds necessary.

(g) The chairman or any two Trustees are entitled to convene a meeting of Trustees.

(h) A minimum of four Trustees shall form a quorum for any meeting of Trustees.

(i) The Trustees may from time to time make such rules and regulations for managing the affairs of the Trust not inconsistent with the main object of the Trust as they may think fit and may from time to time alter or vary the same.

(j) Any Trustee may retire or resign at any time by giving a notice in writing without assigning any reason whatsoever and without being responsible for any costs occasioned by such retirement or resignation.

10. Every power, authority or discretion conferred upon the Trustees shall be exercised or signified either by some instrument in writing to be signed by all the Trustees or such of them as may be present or by the Resolution of the Trustees or such of them as may be present and vote at any meeting of the Trustees.

11. In case of difference of opinion arising among the Trustees and in all matters wherein the Trustees shall have a discretionary power the votes of the majority of the Trustees for the time being voting in the matter shall prevail and be binding on the minority as well as on those Trustees who may not have voted, and if the Trustees shall be equally divided in opinion the matter shall be decided according to the casting vote of the Chairman. This clause shall also apply to any exercise of the power of authority or discretion of the Trustee by instrument in writing as mentioned in clause 10 above.

13. (a) The Trustees shall be entitiled from time to time to open and maintain banking account or accounts in the name of Trustees or Trust, as the Trustees may think fit, at such bank or banks or post office as they may from time to time decide and may at any time pay or cause to be paid any money forming part of the Trust Fund or the income thereof to the credit of any such account or accounts and either by way of fixed deposit, current, savings, or overdraft account or any such account or accounts may be operated as may be decided by Board of Trustees ;

(b) The Trustees may raise or borrow money required for the purpose of the said Trust on mortgage pledge or Hypothecation of the Trust properties or any part thereof or without any security on such terms as they may in their absolute discretion think fit.

14. It shall be lawful for the Trustees to pull down, renovate, rebuild, alter, adapt improve, add to, or repair any immoveable properties comprised in the Trust, property and to expend there on such moneys out of the Trust Fund or the income thereof as they may think fit ; The Trustees shall also have the power to insure any premises comprised in the Trust Fund against loss by fire, lightning or civil commotion or other risk or losses as the Trustees may think proper from time to time, but no liability shall attach on the Trustees or any of them by reason of any property remaining uninsured in any way. The Trustees shall also have the power after paying all rents, rates, taxes, and other out goings and expenses out of the income of the Trust to set aside out of the balance thereof from time to time such sum of money as the Trustees consider proper to meet the expenses of heavy repair or by way of depreciation or sinking Fund and to utilise the same and the income thereof for heavy repair or for rebuilding or reinstating immoveable properties or erecting new buildings and in the mean time to invest the same in manner authorised by these presents . It shall also be lawful for the Trustees to permit any immoveable property forming part of the Trust Fund to be held used and enjoyed for the purpose of any scheme of charity or other purposes of these presents. The Trustees may also allow the same or any part thereof to be occupied by any employee of their or of any such scheme free from payment of rent or on such terms as the Trustees may think fit.

All moneys arising for or such transfer or other assurance shall be deemed to be part of Trust Fund and shall be applicable accordingly.

16. The Trustees may from time to time appoint one or more Managers, Secretaries, Treasurers, Supervisors, Clerks and other officials and employees and servants as the Trustees may deem expedient and fix their remuneration. In particular, the Trustees shall be at liberty to establish and maintain an office and to employ such person or persons as the Trustees consider necessary to carry out the objects of the Trust and pay out of the income of the Trust such expenses as may be incurred in that behalf. The Trustees shall also have power to form and maintain Provident Fund, Gratuity, Pensions and other funds for the employees and make rules and regulations regarding the same.

The trustees shall have the power at their uncontrolled discretion instead of acting personally to employ and pay any agent (including any banks) to transact any business or to do any act whatsoever in relation to the trust of these presents including the receipt and payment of moneys without being liable for loss and shall be entitled to be allowed and paid all charges and expenses incurred thereby.

No trustee shall be bound to take any steps or proceedings against a Co-Trustee for any breach or alleged breach of trust committed by such Co-Trustee.

20. The trustee or trustees of these presents for the time being may reimburse himself, herself or themselves and pay and discharge out of the funds of moneys of all expenses incurred in or about the execution of the trust or the powers of these presents.

21. If any trustee of these presents shall be a lawyer or a person engaged in any other profession or business he or his firm shall be entitled to charge reasonably for his or their professional services. If any trustee of these presents shall be a broker or sub-broker he or his firm shall be entitled to charge for his or their services including any brokerage payable to him or them.

22. It shall be lawful for the trustees at any time after the death of the settlor if they unanimously agree to continue the trust or to transfer and handover the Trust Fund to the trustees of any other charitable trust or institution whatsoever which may take upon itself the duties of administering and managing the trust of these presents to be used by the said trustees of such other charitable trust or institution on the trust and with and subject to the powers, provisions, agreements and declarations as those appearing and contained in these presents subject to such modifications (including the modifications of the power of appointment of new trustees) as may be necessary or consequent due to the said Trustees of such other institute or institutions becoming the trustees or trustee of the said Trust Fund.

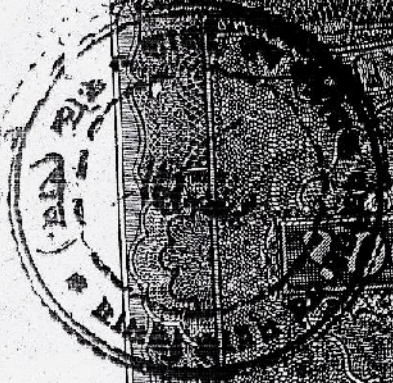

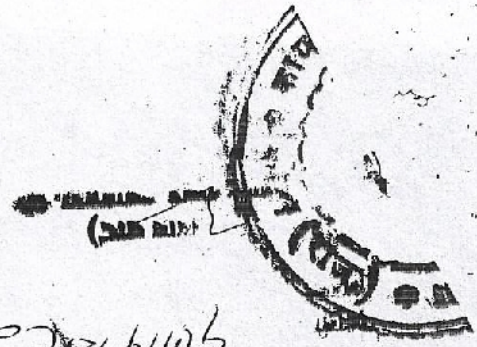

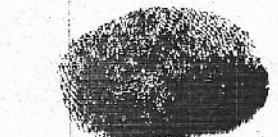

Whereas original Trust Deed was executed in the name of Guru
Nanak Welfare Trust on 23.11.92 and registered on 14.12.92 with
the Dy. Registrar of Registration, Kota.

AND WHEREAS the trustees of the trust have desired to insert
tion/addition in the Constitution of the Guru Nanak Welfare
Trust to improve and achieve the aims and objects of the Trust.

AND WHEREAS the trustees of this Trust have resolved and con-
firmed unanimously to insert/add the following sub clauses in the
constitution of the trust.

Sub clause c(i) of Clause 4 of Trust Deed shall be added as
under:-

(i) To construct, set up and run educational institution namely :
Guru Nanak Public School (English Medium) and other institutions
like colleges, hostels, research centres, laboratories, sports
and play grounds, recreation, welfare clinics, canteens, social
community centres, libraries etc. in the name of "Guru Nanak"
according to guidelines of concerned Central/State Education
Department /board/ university to achieve the aims and objects of
the trust.

Following may be added as sub clauses (i) to (vi) below clause
4(f) of the Trust Deed:-

(i) For the purpose of sub clause c (i) of clause 4, the chair-
man will nominate the Managing Committee comprising of
members upto 21 which will include all the trustees of the
trust.

Members of the Managing Committee, excluding the trustees,
will be for a tenure of two years only from the date of
their appointment.

(ii) He will have the power to dissolve/reconstruct the Managing
Committee or to add, remove and retire any member of the
Managing Committee of the school.

(iii) The office bearers of this trust namely : Chairman, Vice
Chairman, Secretary and Treasurer will be ex-officio, office
bearers of the Management Committee of the school also.

(iv) The Chairman, Vice-Chairman and Secretary of the school
Management Committee will be authorised to communicate or
deal with the Central and/ or State Govt. or with the
concerned departments of the Central and State Govt. or
any other agency in connection with the running of the
Guru Nanak Public School.
